I agree that I shall receive no compensation or consideration of any kind in return for the rights granted by me hereunder other than the opportunity for me to participate in such Program, regardless of whether or not the Program at any time is so exploited by Owner and/or others.
2. I agree that my performance and/or interview and the Program shall be deemed a "work made for hire" as defined in the United States Copyright Act for Owner and Owner's respective affiliates, licensees, contractors, assigns, and others directly or indirectly associated with Owner. Owner shall own the Program together with the performances embodied thereon and all copyrights and any other rights therein and thereto, all of the result and proceeds of Performer's services hereunder throughout the universe in perpetuity, free of any and all claims by me or any person, corporation or other entity deriving any right from me. Notwithstanding the foregoing, if the Program is not determined to be a "work made for hire", I hereby transfer and assign to Owner and Owner's respective affiliates, licensees, contractors, assigns, and others directly or indirectly associated with Owner any and all rights, title and interest, including the copyright, in and to the Program, together with the performances embodied thereon. Owner shall have the unlimited right to use and exploit the Program, as edited or unedited in Owner's sole discretion, all and/or any part of such performance and/or interview, including, but not limited to, my picture, likeness, voice, name and biographical information, for the promotion of, use in, and/or exploitation of the Program or Owner's business and/or such other uses as solely determined by Owner in any and all media, including, but not limited to, television, radio and print, now known or hereafter at any time throughout the universe in perpetuity. Notwithstanding the foregoing or anything contrary contained herein, Owner may refrain from any exploitation of the Program in Owner's sole discretion. I agree that ownership of the performance and/or interview, and the Program in which they appear, and the results of my efforts in conjunction therewith shall for all times and all purposes fully vest in Owner to the exclusion of me and others.
3. I am over 18 years of age and hereby release Owner and Owner's respective affiliates, licensees, contractors, assignees, advertising agencies, and others directly or indirectly associated with Owner from all claims now or hereafter existing which I, and/or others claiming by or through me, may have a right to asset arising under the terms of this Release or from any use, non-use, or editing of my performance and/or interview.

Notwithstanding anything herein to the contrary, Owner hereby grants me a limited, non-exclusive license to use the Program solely for promotional and resume purposes for myself and my acting or other career. I hereby agree and acknowledge that I am not allowed to license, assign, sell or otherwise use the Program for any purpose whatsoever without the prior written permission of Owner.
